

NIHON UNIVERSITY: "CONTROLLED CEREBRAL HYPOTHERMIA THERAPY"

Japanese neurosurgeons have saved the lives of 14 patients out of 20 with acute subdural haematoma associated with widespread brain damage and 6 patients out of 12 with total cerebral ischaemia caused by 30 to 47 minutes cardiac arrest. The patients returned to a normal every-day life and completely recovered their capacity for verbal communication.

"A hasty declaration of so called 'brain death' without trying this therapy could well constitute murder or at the very least premeditated failure to assist and malpractice" (Yoshio Watanabe MD, Cardiac Transplantation: Flaws In The Logic Of The Proponents JPN Heart J. Sept 1997 – Hayashi N. MD, Brain Hypothermia Therapy JPN Med J. July 6, 1996).

Prof. Lodovico Bergamini, professor in neurology at Turin University writes: *"An electroencephalographic graph can be normal even if it is a flat line, that is to say if it is lacking a visible rhythm: for example anxious adults or new born babies can have a flat line and this in itself cannot be completely defined as being pathological"* (Clinical neurology manual).

Explants in 1-5 minutes of a non-beating heart

The organs explanted from persons declared to be "brain dead" are not sufficient, so the transplant liars have developed an authoritarian illegal system to be applied to heart-attack victims who are "prematurely" judged to be hopeless cases.

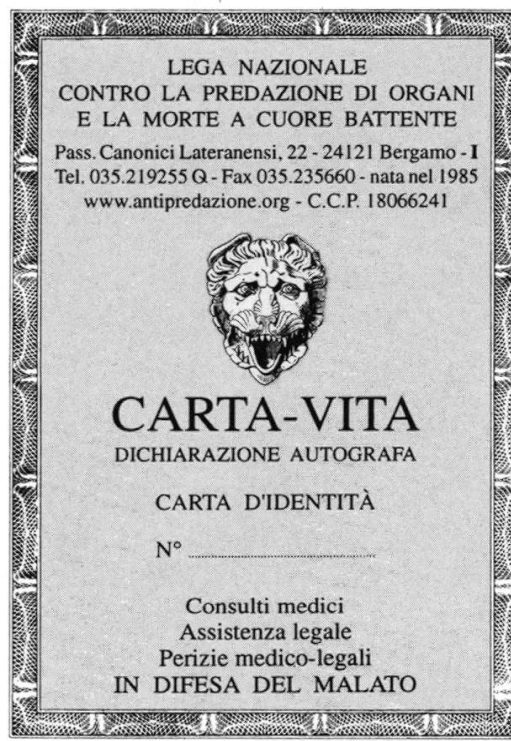
Italian transplanters call it "dead heart donation" to convince us that the donor is dead, but this is not true.

Internationally it is defined as "non heart beating donor" (NHBD), but the brain is still alive.

This means that CP Resuscitation is not carried out even though the heart could recover, and extra-corporeal circulation is used to oxygenate the kidneys and liver, but deliberately obstructing the blood supply to the brain.

If you call 112 (the emergency number) to report a heart attack, you should know that the explant coordinator is the first to be contacted and treatment is immediately carried out with the aim of rapid organ explantation. This takes place as soon as cardiac death is declared, after the 20 minutes as provided by law.
